WAS IT REALLY ALL THAT BAD?

Whew! We made it through another tax filing season. Yeah!

From what I've heard from other preparers, tax season started slowly, probably because of the hold on some refunds, became fairly steady and then was crazy for the last final 10 - 14 days. Are you taking a break now? Or, like many of us, tax season never really ends but the nature of it changes.

Sound familiar? Maybe things weren't as different as we closed out the 2017 tax filing season as I thought: those opening sentences were from my article just one year ago! There are still files and piles that I need to work through before I'm close to feeling done for this filing season.

Did your clients ask as many questions of you as mine did about the 2018 Tax Cuts and Jobs Act? I found taxpayers, in general, feeling negative about the new tax law, until I was able to show them what the impact may actually be on their financial picture. I don't prepare many returns for high income taxpayers and found that for the majority of my clients the new tax law benefits them to some degree.

BITS & PIECES OR BITCOINS?

If you have not yet encountered a bit coin or crypto/virtual currency client don't worry: it is more likely than not that you will. And soon.

Some of the issues which may be involved:

- What are the reporting requirements, if any, for ownership of cryptocurrency? [FINCEN 114 (FBAR)?]
- Can taxpayers utilize section 1031 exchange treatment for cryptocurrencies?
- What are the income tax reporting requirements for crypto currency exchanges?
- What valuation issues might arise from these transactions?
- What are the limitations on loss recognition on crypto currency transactions and exchanges?
- How can taxpayers come into compliance with their reporting requirements to avoid penalties?
- Are crypto currency and bitcoin's a collectable? Are they a capital asset?
- Can you use bitcoins or crypto currency to pay for MI-NATP seminars or NATP dues? [hint: not at the moment.]
- What effects are there on you, as a preparer, if you accept crypto currency as payment for services?
- Your May convention will have a breakout session on this topic.

Your Michigan Chapter of NATP is celebrating its 30th Anniversary. A number of our current members and several others worked hard to establish this chapter, and our charter was received at the National Conference in 1988. From the beginning, education was and still is our primary goal. Marilyn Meredith was hired as an instructor by our first President Larry Semrau for our first seminar in June, 1988 in Lansing.

Your chapter has established itself as a leader in tax education. Many know us for our "2 for 1" seminar inspired by former board member Joe Halfmann. Our "Purely Michigan Tax" seminars (starting out as Michigan Piggyback) are popular and always up to date. We enhance those by having chapter meetings with Michigan Treasury staff each fall, and Michigan City Income Tax Administrators in December.
